## AFFIDAVIT OF ALEXANDER RHODES


My name is Alexander Rhodes. I am older than 18 years of age, I am of sound mind, I have never been convicted of a felony, I am personally familiar with the facts stated herein, and I am fully capable of making this affidavit. I swear under penalty of perjury that the statements contained herein are based on my personal knowledge and are true and accurate.

In 2011, I founded *NoFap*® while I was a student at the University of Pittsburgh. *NoFap* is a website that helps people overcome compulsive Internet pornography use (often referred to as porn addiction). As of June 05, 2019, our online forum at NoFap.com has 241,766 members and our Reddit.com-hosted "subreddit" page has 446,220 subscribers. Our usership, social media following, and web traffic currently make us one of the most popular online destinations for people who struggle with compulsive porn use.

Dr. Nicole Prause appears to vehemently disagree with the concept of "porn addiction" and has expressed criticism of me and my website since as early as May 30, 2016. On July 8, 2016, in response to an article published in *The New York Times* about my work, Dr. Prause referred to me on Twitter as "some neckbeard on the internet." Her criticisms and insults continued, such as on September 28, 2016 (calling me a "fake") and October 5, 2016 ("goofiness/profiteering" and "antimasturbation fake claims of 'superpowers' from stopping healthy habit"). A true and accurate copy of these statements is attached and incorporated herein as Exhibit "A".

Since then, Dr. Prause has escalated from occasional criticism or insults about me to unrelenting defamation. For example:

1. On October 4, 2016, I expressed doubt on Twitter about Dr. Prause's dubious claims that another porn-skeptic, Gary Wilson of Oregon, physically stalked her outside of her residence. To poke fun at what I perceived, and continue to perceive, as a false allegation, I posted to Twitter in response to @YourBrainOnPorn a humorous photograph of a man hiding in a bush. Alongside the image, I asked @YourBrainOnPorn, "How did you get to another state so quickly to stalk? You also behind all of the mysterious clown sightings?" I retrieved the image, which was used in parody, via a web image search engine. In response, Dr. Prause falsely claimed "under penalty of perjury" that she was authorized to act on behalf of the copyright holder, and submitted a DMCA takedown on the Twitter post, successfully censoring my criticism. Dr. Prause has publicly mischaracterized my disbelief of her farfetched claims that Gary Wilson physically stalks her as sexism, encouraging stalking, and



threatening stalking. For example, she falsely characterized my skepticism of her allegations as "encouraging stalking by Wilson" in an infographic that she often shared online as an example of "Anti-Porn Activists Sexism." A true and accurate copy of these statements is attached and incorporated herein as Exhibit "B".

- 2. On December 12, 2016, Dr. Prause published the following libel about my website on Twitter: "@NoFap calendar (an untested anti-porn profiteer) drove gay teen to suicidal feelings," citing a story that had nothing to do with myself or my website and didn't even mention "NoFap" in any instance/medium of media. A true and accurate copy of this statement is attached and incorporated herein as Exhibit "C".
- 3. In March of 2018, I believe that Dr. Prause or an associate of Dr. Prause edited Wikipedia's page about my website. The editor's accounts were all banned for "sockpuppetry," which Wikipedia defines as improperly using multiple accounts to "deceive or mislead other editors, disrupt discussions, distort consensus ... or otherwise violate community standards and policies." In addition to editing a very limited number of pages about porn addiction and the page about NoFap, these illicit accounts also made copious and highly flattering additions to Wikipedia's page about Dr. Nicole Prause. The edits to the page about NoFap included removing a positive reference that describes benefits of abstaining from pornography, along with adding this grossly inaccurate representation of a graduate student research paper: "Recent peerreviewed data highlighted considerable misogyny and poor understanding of sexual relationships in this online community." In fact, this paper didn't use the word "misogyny" to describe the website or its users once. It was an analysis of comments posted in just the first 10 threads (a tiny amount, considering there are 100,000s of threads in total) that appear under a search for "masculinity" on our social media subreddit, not the main website itself. It was not a quantitative (or as Dr. Prause put it, "systematic") study. The paper itself states that "we wish to highlight that the data presented is not intended to be read as representative of NoFap as a whole, but to present how some users express a particular investment in masculinity and its constitution." A true and accurate copy of these statements is attached and incorporated herein as Exhibit "D".
- 4. On October 27, 2018, Dr. Prause collaborated with somebody I believe to be her friend, Dr. David Ley, to promote a *Psychology Today* blog post article, authored by Dr. Ley, insinuating that I and other porn-skeptics have tangible ties to Neo-Nazis and fascists. An editor at *Psychology Today* later removed my name from the article. On Twitter, she falsely claimed that NoFap "repeatedly promoted Proud Boys for years!" This was especially upsetting for me, as it occurred the same day as the Pittsburgh *Tree of Life* synagogue mass shooting. I grew up in this community and still reside in the Greater Pittsburgh Area. Choosing that exact day to collaborate in defaming me with an antisemitism smear campaign was inappropriate and distressing. A true and accurate copy of this statement is attached and incorporated herein as Exhibit "E".
- 5. On October 28, 2018, Dr. Prause claimed that a "NoFap member threatened to rape a scientist never disavowed by NoFap." While Dr. Prause described the person as a "NoFap member," it was actually a Twitter user unaffiliated with the website whose account incorporated our website name "NoFap" in their display name without authorization. In fact, the Twitter user that she was referring to was previously reported to Twitter by NoFap and has berated me repeatedly, as well. She continued, "Still no disavowal/apology to me for **promoting someone to**

threaten to rape me." Obviously, neither NoFap nor I had done anything to apologize for or disavow, nor had we promoted anyone to rape anyone. Dr. Prause also falsely claimed that "[We] directly incite and fai[I] to address misogyny, fascism, and rape threats" and that "NoFap is [a] hate group." A true and accurate copy of these statements is attached and incorporated herein as Exhibit "F".

NoFap hosts a very diverse and inclusive community and explicitly forbids hate speech, threats, or calls for harassment/violence across the platform. Any tangible threats posted by a user on our forum, although I cannot recall any occurring against Dr. Prause, would be relayed to the appropriate law enforcement agencies. We think our website is noteworthy in that it specifically unites people from various backgrounds and beliefs together to overcome a common issue. It's absurd to attempt to smear this website as a "hate group." Additionally, the volunteer moderation team on the forums strictly enforces a set of rules, regularly removes rule-breaking content, and bans accounts that register to spread the type of content that Dr. Prause falsely claims that NoFap supports, incites, and promotes. A true and accurate copy of the relevant sections of NoFap's forum policies is attached and incorporated herein as Exhibit "G".

- 6. On October 29, 2018, in response to @NoFap responding to defamation published by Dr. Prause, Dr. Prause called me a "serial, misogynist harasser" and falsely claimed that she filed a report against me, stating that she "now [has] an FBI cyberstalking report." A Freedom of Information Act ("FOIA") request to the FBI revealed that no such report actually exists. For days afterward, Dr. Prause posted defamatory comments on Psychology Today, under Dr. Ley's article, including the following phrases:
  - "Promoting discrimination against protected groups."
  - "If you visit this website, you will be supporting and further misogyny, above and beyond the antisemitism evidenced from Dr. Ley's original piece"
  - "[Alexander Rhodes] is stalking women online in violation of no-contact orders."
  - "NoFap is happy to support the misogyny"
  - "NoFap threatens to rape and stalk women"

A true and accurate copy of these statements, the FOIA request, and the FBI's response, is attached and incorporated herein as Exhibit "H".

- 7. On November 26, 2018, Dr. Prause contacted a senior reporter at *The Huffington Post* to pitch a story about me, falsely stating to the journalist in a public Twitter message that NoFap is an "anti-masturbation, anti-porn" group and that I "long promoted" *Proud Boys*, and that our followers threaten rape and stalking online. (Note: I didn't even know what the political group "Proud Boys" was until researching it after Dr. Prause falsely accused me of repeatedly promoting it "for years.") A true and accurate copy of these statements is attached and incorporated herein as Exhibit "I".
- 8. On November 30, 2018, Dr. Prause on Twitter corresponded with a journalist at *NewStatesman.com* falsely stating that she had "rape and stalking threats and harassment from NoFap and filed with FBI. Will share report [number] [using Twitter's private messaging

system]... Founder Rhodes work w ProudBoys extremists, so worth getting on FBI radar. Scientists know NoFap misogyny well."

In response to a defamatory Twitter post by a pornography website *xHampster*, Dr. Prause reached out to them publicly: "NoFap followers also threatened to rape me. Founder violated no-contact, joked about physically stalking me, & has FBI report for it. DM me if you want report number to add."

Again, the FBI has confirmed to me through a FOIA request that the alleged report does not exist. Nor does a no-contact legal order exist that I could possibly violate. A true and accurate copy of these statements is attached and incorporated herein as Exhibit "J".

9. On March 11, 2019, in response to an article quoting me published in *The Guardian*, Dr. Prause publicly stated that the journalist Amy Fleming was "conned by fake experts" and **posted a photograph of me (with my full name included) alongside of "There are actual experts who study this topic & don't threaten to rape & stalk women" (tagging the journalist and** *The Guardian***, admonishing them to check their sources). A true and accurate copy of these statements is attached and incorporated herein as Exhibit "K".** 

Dr. Prause's numerous allegations are false and defamatory. The allegations about rape threats and stalking are particularly offensive. A FOIA request to the FBI revealed that Dr. Prause didn't actually file any false or frivolous report about me, contrary to what she alleges and attempted to get published by media outlets. Any direct communication between Dr. Prause and myself has occurred publicly through the social media website Twitter.com. I have never met Dr. Prause inperson or attempted to communicate with Dr. Prause through any private medium such as email, text message, phone call, social media direct message, letter, etc. Furthermore, I have never initiated public Twitter communication with or about Dr. Prause outside of infrequent refutations to her escalating insults and defamation. I would never willingly subject myself to unnecessary communication with Dr. Prause. Therefore, any existence of or need for a "no-contact order" against me is entirely fictitious.

I have never supported or promoted misogyny, antisemitism, or other forms of discrimination against protected groups. I have never been affiliated with or promoted "Proud Boys". I have never supported, incited, or promoted anyone to send anyone else stalking threats or rape threats. I have never been subject to a no-contact or restraining order from anyone. I have never threatened to stalk anyone. I have never threatened to rape anyone. I have never stalked anyone online or offline.
