

**Affidavit from Bradley Green, Ph.D.  
Professor of Psychology and Director of USM Psychology Clinic  
The University of Southern Mississippi.**

My name is Bradley Green. I am older than 18 years of age, I am of sound mind, I have never been convicted of a felony, I am personally familiar with the facts stated herein, and I am fully capable of making this affidavit. I swear under penalty of perjury that the statements contained herein are based on my person knowledge and are true and accurate.

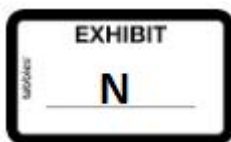
I started working at The University of Southern Mississippi in the fall of 2003, as an assistant professor, and from August 2015 to the present, I have been a professor of psychology at The University of Southern Mississippi. In addition to my teaching duties, I also serve as the director of the USM Psychology Clinic, maintained by our program, and I conduct research and publish in the peer-reviewed literature. I have a variety of research interests including the mental health and suicide risk of military personnel, personality factors related to psychopathology, and various issues relating to sexual addiction. A true and accurate copy of my condensed CV is attached and incorporated herein as Exhibit "A".

In 2015, I was the lead author in an article published in *Sexual Addiction and Compulsivity*. The full citation to the article is as follows:

Green, B. A., Arnau, R. C., Carnes, P. J., Carnes, S., & Hopkins, T. A. (2015). Structural congruence of the Sexual Dependency Inventory – 4th Edition. *Sexual Addiction and Compulsivity*, 22, 126-153.

Dr. Nicole Prause falsely accused me and my colleagues of fabricating the data and/or falsifying our research as it relates to this article. She claims that she has filed a complaint against me with the American Psychological Association (APA), and she did file a complaint with the editor of the journal (*Sexual Addiction and Compulsivity*), and with the publisher of the journal, Taylor & Francis. All these complaints contain false allegations. None of the data is fabricated, and none of the analyses have been falsified. I do not have copies of the actual complaints she filed with these organizations, but I do have several emails and other communications wherein Dr. Prause described to my colleagues and others the complaints that she says she filed with these organizations. I believe that Dr. Prause made these allegations because she disagrees with the conclusions published in the paper. The following is a more detailed description of Dr. Prause's harassing behaviors and false accusations against me and my co-authors:

1. December 15, 2016, Dr. Prause requested that I send her the data used in our research for her to use. For a number of reasons, I declined to give her access to the data. I asked for Dr. Prause to detail the errors she claimed were in the article so I could correct them, and she declined.
2. On December 21, 2016, Dr. Prause sent me an email indicating she would contact the editor of the journal that published the paper to investigate fabrication of data



or falsification of results. A copy of the email is attached and incorporated herein as Exhibit "B".

3. On December 23, 2016, I received notice from Taylor & Francis, the publisher of *Sexual Addiction and Compulsivity*, indicating that Dr. Prause had contacted them. On January 3, 2017, I received a message from Bailey Gunn, who was the managing editor at Taylor & Francis, stating that the editor of the journal needed to ask Dr. Prause for more specific information about her concerns, stating: "If she is unable to provide specific evidence regarding her claim, we cannot move forward with investigating it." A copy of this email is attached and incorporated herein as Exhibit "C". I was never given any detailed account of Dr. Prause's specific complaints to the publisher.
4. On January 18, 2017, I received an email from Dr. Prause stating that she will submit ethics complaints to various organizations "tonight" unless she has reason to believe that she is going to get the data she demanded. The email further states: "Violating the ethics of your profession, I must believe the SDI data are fabricated". A copy of this email is attached and incorporated herein as Exhibit "D".
5. On that same day (January 18, 2017), Dr. Stefanie Carnes, a co-author of the article in question, wrote Dr. Prause stating:

"IITAP is committed to running an ethical practice based on sound research. ***Your false accusation that the SDI data is fabricated is not well taken.*** Given your history with IITAP, we submitted concerns regarding your use of the data to the appropriate organizations and to our attorneys. We await a determination from them as to how to proceed. No ethical rules have been violated and IITAP has made a good faith effort in this matter. If you continue to defame IITAP, its founder, and our CSAT providers, we will not hesitate to take appropriate legal action against you..

The same day, Dr. Prause responded:

"Hi Stefanie,

I am very familiar with your legal threats, as are dozens of other providers. ***Your history of fabricating press releases is consistent with data fabrication.*** I am on solid ground and welcome the challenge.

Complaints sent.

NP".

A true and accurate copy of this email chain is attached and incorporated herein as Exhibit "E".

6. On 9/18/2017 Dr. Stefanie Carnes contacted Bailey Gunn at Taylor & Francis to arrange for secure delivery of the requested dataset so Taylor & Francis could investigate the claims against us. We did not hear back from Taylor & Francis until 6/6/2018.
7. On April 5, 2018, Dr. Prause sent emails to Michael D. Anestis, Ph.D, who is colleague of mine in the Psychology Department at The University of Southern Mississippi. The emails make a number of false and derogatory statements about me including that I “lied” to her and that I have a “history of deception”. She also stated that she filed a complaint with the American Psychological Association about me. Specifically, she wrote to Dr. Anestis:

“You are listed as the Chair of clinical admissions. *It would be difficult to attract students to a program struggling to maintain APA accreditation.*

Dr. Green is aware that *he lied* to myself and the journal about the data being “proprietary”, so *I do not expect to make any progress with someone with a history of deception.*

*I think this makes clear I need to go ahead and file the complaint with the APA, in addition to the journal following up. Done.*

Dr. Anestis’ response to Dr. Prause included the following: “Also, your personal attacks on my colleague are both unnecessary and unprofessional.” A true and accurate copy of the email chain between Dr. Prause and Dr. Anestis is attached and incorporated herein as Exhibit “F”.

8. On April 5, 2018, Dr. Prause sent an email to another colleague, Dr. Sarah Jordan, who is the Director of Clinical Training for our program. In the email, she stated that she filed a complaint against me with the APA and that she also filed a separate complaint with the journal, who supposedly was continuing its investigation into her allegations. Dr. Prause then suggested to Dr. Jordan that she encourage me to resolve the “ethics violation” or could Dr. Jordan refer her to the “appropriate ethics contact at your university for Dr. Green's deception to conceal data?” A true and accurate copy of this email is attached and incorporated herein as Exhibit “G”.

I have never been contacted by the American Psychological Association (APA) to inform me of any ethics complaint made against me by Dr. Prause or anyone else.

9. On 4/9/2018 Dr. Prause enquired of our Institutional Review Board whether my university is party to an ongoing study of genetic factors related to sex addiction, a study on which I am a Co-Investigator. The study is listed at NIDA, so I believe that she was looking for some other avenue to attack me.
10. On 6/6/2018 Anna Harp, Managing Editor, US Behavioral Science & Social Care Group, Routledge, Taylor & Francis Group, contacted me and Dr. Stefanie Carnes, informing us she had taken over from Bailey Gunn as our primary contact for Taylor & Francis. She asked at this time that we send her the deidentified dataset as an encrypted file.
11. On 6/6/2018 I sent the requested deidentified and encrypted dataset to Anna Harp at Taylor & Francis so an independent statistical expert of their choosing could investigate any and all claims made against us by Dr. Prause.
12. On 5/7/2019 (11 months later) I received this email from Anna Harp, exonerating us from Dr. Prauses's false claims:

Dear Dr. Green,

I apologize for not contacting you sooner. And thank you for your cooperation by providing your raw data. Throughout the investigation we followed COPE guidelines, particularly this COPE flowchart: <https://publicationethics.org/files/Fabricated%20data%20B.pdf>. You are correct that we found an independent statistical reviewer to examine the data. They were able to verify the reproducibility of the data. The reviewer assessed your data and the analyses reported in the article and verified the reproducibility of the data. To ensure an objective assessment, the statistical reviewer was independently selected and they have demonstrated knowledge and experience in best practices in data analysis (including measurement development and validation) in sexual science. The reviewer was asked to specifically investigate the complainant's concerns focused on the following analytic discrepancies: *"the methods state intentions to run tests that are actually never conducted in the results. The degrees of freedom reported do not match the sample size reported. Then, other broader concerns are the use of an exploratory statistic then adding items without statistical justification, which nullify the reported psychometrics."* The reviewer termed these under "analytic flexibility" concerns and summarized that while the analytic flexibility in the authors' approach does appear to be considerable, "their approach is not unusual compared to other PCAs and factor analyses reported in the sexual science literature".

After receiving the reviewer's assessment, we notified the complainant of these findings and informed her that we will not be pursuing this case any further. I also notified the Editor of *Sexual Addiction & Compulsivity* with the results of the independent review. Thank you for your patience in this matter as I know it has been protracted.



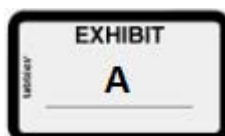

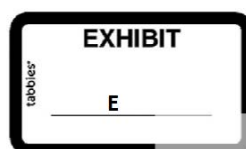

I requested data from Dr. Green from a paper he published in 2015 when I discovered numerous statistical errors. APA rule 8.14 requires disclosure. He refused, claiming it was proprietary (see below). His co-author, Stefanie Carnes, verified that the data were not proprietary, as they "often" share the data with universities (email available).

The journal has asked Dr. Green to share the data. He continues to refuse. I see that USM is APA-accredited. My intention is to file an ethics complaint against Dr. Green based on this accreditation and violation of APA rule 8.14 on data sharing. I called the APA ethics office to verify that his refusal to data share is not valid.

I realize the negative impact having to deal with APA complaints can cause a department. If I can avoid this, I would strongly prefer to receive the data now, rather than after an ethics investigation.
