DECLARATION OF GARY WILSON

My name is Gary Wilson. I am older than 18 years of age, I am of sound mind, I have never been convicted of a felony, I am personally familiar with the facts stated herein, and I am fully capable of making this affidavit. I swear under penalty of perjury that the statements contained herein are based on my personal knowledge and are true and accurate.

I am the author of a book entitled *Your Brain On Porn: Internet Pornography and the Emerging Science of Addiction*. Since 2010, I have also hosted a large informational website (12,000+ pages) featuring relevant research on pornography's effects among other items of interest: www.yourbrainonporn.com.

One apparent result of running this website, cataloging new research, and posting critiques of questionable research, is that for nearly seven years, I have been the target of disturbing attacks by Dr. Nicole Prause, her colleagues and their press sympathizers. It is difficult to put into words, and nearly impossible to catalog, the degree of harassment, fabrication and cyberstalking to which I have been subjected. Incidents include multiple false claims that I have committed crimes. Some years ago, I was forced to begin documenting her behavior as a way to cast sunshine on her activities.

The incidents are too numerous to list in an affidavit, even with extensive exhibits. A limited sample appears below, taken from the obscure pages on my website where I catalog her ongoing harassment of others and myself.

1. Dr. Prause has sent me the following series of spurious, threatening cease and desist letters warning me to stop doing things that I have not done:
 - a. October 15, 2015
 - b. May 5, 2019

- c. July 3, 2019
- d. August 27, 2019
- e. October 10, 2019
- f. November 19, 2019

Typically, she then posts her letters online, and links to them as if they establish my wrongdoing. In a striking invasion of my privacy, she had a copy of the July 3, 2019 letter (addressed to my attorneys) hand delivered to my home at around 10pm. A true and accurate copy of that letter is attached and incorporated as Exhibit “A”.

2. Dr. Prause has been part of an extensive smear campaign endeavoring to paint me and others in the porn-recovery movement as fascists and white supremacists. This campaign ramped up to new heights concurrently with the Pittsburgh synagogue shootings in October, 2018. With Dr. Prause’s admitted collaboration, her close colleague David Ley published a defamatory *Psychology Today* article targeting me (yourbrainonporn.com), Gabe Deem (RebootNation) and Alexander Rhodes (Nofap): [“Why Fascists Hate Masturbation: The rise of nationalism coincides with anti-masturbation movements.”](#) It appears from another article, a true and accurate copy of which is attached and incorporated as part of Exhibit “B,” that Ley is being paid by StripChat, a subsidiary of xHamster (a porn giant). Then, in August, 2019, in the wake of two mass shootings (El Paso and Dayton) Dr. Prause posted tweets and screenshots trying to connect me, my website and Nofap to Nazis and white nationalists. Dr. Prause and her colleagues have also tried to paint me in a false light as being in sympathy with white supremacists because I once appeared on a podcast to discuss internet-porn related problems – not race politics – with a man named Stephen Molyneux. (Molyneux has been a guest on various mainstream programs, but was eventually found to have made some statements with which I and many others strongly disagree.) To this day, Dr. Prause collaborates with various allies to promote and amplify her smear campaign. True and accurate examples of screenshots of tweets by Dr. Prause and her apparent alias @BrainOnPorn are attached and incorporated as part of Exhibit “B”.
3. I have known of Alexander Rhodes for more than seven years. I regularly monitor a variety of recovery websites, including his, to collect and compile recovery self-reports. I have never witnessed Rhodes threatening or stalking Dr. Prause, or encouraging anyone else to threaten, stalk or rape Dr. Prause.
4. I have never witnessed Rhodes encouraging hate groups of any kind. Rather, I have witnessed him doing everything in his power to keep members of such groups off of his platforms.
5. I have seen Dr. Prause repeatedly, publicly disparage not only Nofap, but also Rhodes individually. On multiple occasions, she has publicly claimed that she has reported Rhodes to the FBI for misconduct. She has publicly described Rhodes as a physical stalker and cyberstalker, as a misogynist, as a serial harasser, as the subject of a no-contact/restraining order, as a promoter of “Proud Boys,” and as a promoter of rape and violence against women. Following Rhodes’s filing of his defamation lawsuit, Dr. Prause tweeted that she had contacted the FBI concerning Rhodes. In one tweet Prause stated “The FBI has asked me to make clear that the donations going to Alexander Rhodes of NoFap are fraud”

(11/12/19). In a second tweet Prause stated that Rhodes would soon be charged with “criminal larceny” (11/14/19). Around this time, Dr. Prause’s presumed Twitter alias (@BrainOnPorn) stated that “Rhodes sends violent trolls after female neuroscientist, then sues her for distress.” True and accurate screenshots of tweets by Dr. Prause and her apparent alias @BrainOnPorn are attached and incorporated as part of Exhibit “C”.

6. While publicly, repeatedly claiming I am wrongfully attempting to suppress her First Amendment rights, Dr. Prause has made multiple attempts to censor my website, including at least two serious attempts to have it taken down entirely. She apparently objects to my site factually documenting some of her extensive malicious activity. Her censorship attempts that I know about include (details below list):
 - a. Multiple groundless DMCA takedown requests to have images of her many tweets removed from my site.
 - b. An attempt to trademark my website’s long-established URL (www.yourbrainonporn.com), as well as an attempt to trademark the name of my website and book (“Your Brain On Porn”).
 - c. A letter threatening to sue my webhost Linode unless it removed my website.

a. DMCA demands

True and accurate copies of Dr. Prause’s failed DMCA demands relating to pages on my website that contain screenshots of tweets by her and @ BrainOnPorn (her apparent alias) are attached and incorporated as Exhibit “D”.

b. Trademark application to gain control of my site, and infringement

In January, 2019 Dr. Prause attempted to trademark (http://tsdr.uspto.gov/#caseNumber=88281342&caseType=SERIAL_NO&searchType=statusSearch) my website’s long established URL (“yourbrainonporn.com”) as well as the title of my book (and website), in order to gain control of my website. In addition to her trademark application, in mid-April, 2019 her close colleague Daniel Burgess (or perhaps Dr. Prause herself) set up an “impostor” website (which is believed to be managed by Dr. Prause). It was first called www.sciencearousal.com. Swiftly, however, it changed its name to www.realyourbrainonporn.com, a name that infringes on my trademarks, and which is designed to divert traffic from my website. The site proclaims itself to be the “real” (or genuine) Your Brain On Porn. Among other efforts to confuse visitors, the browser tabs for the new site feature the exact name of my website (not the new site’s name). Moreover, the press release about the impostor site claims to be from Ashland, OR where I live (and Burgess and Prause do not). Burgess was ultimately revealed as the nominal owner of the trademark-infringing URL www.realyourbrainonporn.com. However, Dr. Prause’s lawyer Wayne Giampietro Esq. represents both Burgess and herself. My attorneys sent Dr. Prause a Cease and Desist letter, and months later she dropped her trademark application. However, the infringing website has not changed its name as requested. True and accurate screenshots of Dr. Prause’s trademark application and a copy of my attorneys’ letter, and are attached and incorporated as Exhibits “E & F”.

The infringing website’s associated infringing Twitter account (@BrainOnPorn) also appears to be managed by Dr. Prause and, perhaps, her colleagues (presumably including

Burgess). It is confusingly similar to my account in terms of design, and its header says “Real Your Brain On Porn.” Already people trying to link to my Twitter account have mistakenly tweeted it instead. It regularly tweets defamatory material in the same vein that Dr. Prause herself has tweeted and posted for years. True and accurate copies of a design comparison and evidence of consumer confusion are attached and incorporated as Exhibit “G”.

c. Legal threat to my webhost

On November 19, 2019 Dr. Prause’s attorney Wayne Giampietro wrote to my webhost threatening it with legal action unless it took down my website entirely (www.yourbrainonporn.com). His theory was that I had Prause’s home address on my website (as part of the screenshot of the public trademark application she filed for my site’s URL). Months after I placed an image of her trademark application on my site, she claimed her participation in the “Safe At Home” program made displaying her trademark application address a violation. In fact, the address in her application was not her home address. (I know because she could not be served at that address.) Long after she enrolled in the “Safe At Home” project, Prause herself still publicly displayed the application address as her LinkedIn address. Nevertheless, I have since redacted the address. A true and accurate copy of Wayne Giampietro’s letter to my webhost is attached and incorporated as Exhibit “H”.

7. In August, 2019, the Twitter account that appears to be managed by Dr. Prause (@BrainOnPorn) commenced a smear campaign against me, claiming falsely that I had hundreds of URLs of Mormon-themed pornography on my website (www.yourbrainonporn.com). This fraudulent claim was quickly exposed as a ruse, but @BrainOnPorn tweeted more than a hundred times over the course of 4 days insisting that I had a secret Mormon-porn fetish. The tweets were directed to various key public figures and professional organizations, attempting to smear my reputation as widely as possible. Among the Mormon-porn smear tweets were three false claims that I had committed actual crimes: That I physically stalk women; that I have made death threats; and that I engaged in criminal computer intrusion. The latter was in response to my tweet demonstrating precisely how anyone can insert false, nonexistent links into the internet archive site (“Wayback Machine”) that @BrainOnPorn had linked to as “proof” of my supposed Mormon-porn fetish. A true and accurate copy of my attorneys’ October 4, 2019 cease and desist letter (with tweets) is attached and incorporated as Exhibit “I”.
8. The phony Mormon-porn smear campaign extended to emailing acquaintances of mine, implying that I am dangerous and claiming that my motivation for managing my Your Brain On Porn brand and speaking about the risks of internet porn consumption was to gain access to young Mormon women. (From the email: “He may have joined the movement to get access to those girls. He has not denied that the text was on his website; he only claims that it is some conspiracy against him. This is what predators do.” (Note: there was never any “[Mormon-porn] text” on my website.) As a man who has been happily married for almost 20 years, this smear is particularly offensive. A true and accurate copy of one such email is attached and incorporated as Exhibit “J”. Note that the email was sent from the

URL (“sciencearousal.com”) that was used, apparently by Dr. Prause, before the infringing URL “Realyourbrainonporn.com” took its place.

9. In November, 2019, the Twitter account (@BrainOnPorn) tweeted the personal LinkedIn page of the mother of my son. @BrainOnPorn later deleted the tweet, but I interpreted it as a threat that Dr. Prause (who appears to manage @BrainOnPorn) and her colleagues might involve my son or my ex in their ongoing harassment. A true and accurate copy of such tweet is attached and incorporated as Exhibit “K”.
10. On December 16, 2019, Dr. Prause pinned a tweet to her personal Twitter account (@NicoleRPrause), publishing two of the pleadings she had filed earlier in connection with her failed Motion to Dismiss in the defamation lawsuit *Hilton v. Prause*. (She had made these items available to a website called www.reason.com, and linked to them there – without mentioning that her Motion to Dismiss had been denied.) One of these items is an astonishing 86-page affidavit. In it, she and two of her colleagues attack many people. However, I seem to be its prime target. It mentions my name some 220 times, defaming me repeatedly. (I am not a party to *Hilton v. Prause*, but I filed an affidavit at the request of plaintiff Dr. Hilton.) Among other untrue and misleading claims about me, Dr. Prause falsely accuses me of several crimes, including that Alexander Rhodes and I engage in the criminal acts of stalking women in person, “white supremacist death threats,” and computer intrusion (which she claims to have reported to the FBI). She disseminated her misleading document widely and publicly, not only through the Reason.com article, but also via YouTube and numerous Twitter posts. True and accurate copies of relevant tweets are attached and incorporated as Exhibit “L”, as is a link to my rebuttal.
11. In April, 2018 Dr. Prause filed a false police report about me with the Los Angeles Police Department (LAPD) wherein, among other untrue allegations, she claimed that I appeared near her home in a sleeping bag, armed with a long-sleeved sweater. I cannot recall having been in Los Angeles since I first heard of Dr. Prause. I have never stalked anyone. To my knowledge, no police investigation of me has ever been conducted by LAPD or any other law enforcement agency. I first learned of her false report almost a year later in March, 2019 when Dr. Prause persuaded student editors Karley Betzler and Samantha Stroozas at University of Wisconsin – Lacrosse to publish her false report online (“The Racquet Investigates: Fight the New Drug”) and mischaracterize its contents. University authorities eventually removed it after I objected. I am informed by the LAPD that reports such as the one published are not public documents, and that only the person who files the complaint can obtain a copy. A true and accurate copy of an excerpt from the newspaper article where the false police report was published and Dr. Prause’s full police report, are attached and incorporated as Exhibit “M”.
12. In the spring of 2018, someone filed a malicious report with the Oregon Board of Psychology claiming that I was practicing psychology without a license. I found out about it in July, 2018 when I received a letter from the Board exonerating me, a true and accurate copy of which is attached and incorporated as Exhibit “N,” explaining that they could not reveal who had filed it. I know of no person other than Dr. Prause who would make such a

false accusation. I have documented multiple baseless, malicious reports Dr. Prause has filed against others.

13. In March, 2018, Dr. Prause began publicizing an unfounded rumor that I had been fired from the position I last held as Adjunct Instructor at Southern Oregon University. True and accurate copies of a sampling of the documents authored by, or containing statements by, Dr. Prause wherein she claimed that I had been fired are attached and incorporated as part of Exhibit "O". Dr. Prause also falsely stated in an article on Mikesouth.com (reproduced truly and accurately and attached and incorporated as part of Exhibit "O") that my book proceeds directly profit me, when in fact they go to a registered educational charity. I am affiliated with the charity, but not employed by it. Nor do I serve on its board. The accusations are untrue. I was not fired, but had voluntarily ended my employment because of an acute physical illness. I had to obtain an un-redacted copy of my records and make them public in an attempt to counter the false, public statements made by Dr. Prause. I confirmed with the University's general counsel that Dr. Prause is the only person (apart from myself) who has ever requested my employment records. True and accurate copies of these related documents are attached and incorporated as part of Exhibit "O".
14. On March 3rd 2018, Dr. Prause posted a defamatory article on Quora.com containing the redacted copies of my employment records falsely stating that Southern Oregon University had fired me. Over the next two days Dr. Prause posted ten more demeaning and untruthful comments about me and my employment, all containing a link to her defamatory Quora article. I reported Dr. Prause to Quora for violation of terms of service and harassment. Quora permanently banned Dr. Prause. True and accurate copies of Prause's Quora article and evidence of Dr. Prause's banned account, are attached and incorporated as Exhibit "P".
15. Dr. Prause apparently defamed me to the organizers of the 2018 European Society for Sexual Medicine/International Society for Sexual Medicine conference, causing the ESSM to cancel my keynote address. On January 24, 2018, 12 days after my ESSM keynote address was canceled (no details about which were given to me or made public), Dr. Prause tweeted in a thread about "gw" (Gary Wilson) that I "just got removed for an actual good reason from a conference," that I am "losing [my] sh*t," and that "assuming some mental struggles seems very reasonable." She supplied no evidence for any of her insults. On March 11, 2018, she falsely accused me of "trying to sneak in science conferences using fake credentials." On Feb. 16, 2019, Dr. Prause tweeted that "a talk" at the ESSM 2019 "was removed for fraud" and giving "false credentials." Immediately below, she tweeted a picture of me, and misrepresented a paper that I co-authored with 7 US Navy physicians. I engaged in no fraud, and I made my credentials perfectly clear to the organizers who initially invited me. True and accurate copies of Prause's social media posts, and ESSM emails are attached and incorporated as Exhibit "Q".
16. For years, Dr. Prause has repeatedly stated on social media that she has reported me to a range of authorities for "physically stalking" her.

- a. For example, she claims to have reported me multiple times to the FBI. True and accurate copies of sample statements, my FOIA request to the FBI, and the FBI's letter confirming that no such reports existed, are attached and incorporated as part of Exhibit "R".
- b. In October, 2016 Dr. Prause placed a PDF on AmazonAWS with screenshots of emails involving Washington University PD Patrolman Tim Dennis (St. Louis) warning him falsely that I intended to stalk Dr. Prause at the St. Louis AASECT conference. I have neither expressed nor harbored an intention to attend any presentation by Dr. Prause. A true and accurate copy of the PDF is attached and incorporated as part of Exhibit "S".
- c. For several years Dr. Prause used numerous aliases, social media accounts, and ultimately her own email accounts and an Amazon website, to falsely claim that she had reported me to the LADP and UCLA PD for stalking. After more than 6 years of these online claims, I have never been contacted by any police department or agency. True and accurate copies of some of Dr. Prause's statements are attached and incorporated as part of Exhibit "T".

Note: I have never attended, threatened, or desired to attend any gathering where Dr. Prause was present. Nor, to my knowledge, have I visited any city where she was present. I have certainly never stalked her.

- 17. In 2015 and 2016, Dr. Prause misused confidential information she obtained while reviewing a scholarly article I co-authored with 7 US Navy physicians ("Is Internet Pornography Causing Sexual Dysfunctions? A Review with Clinical Reports"). She did so in violation of ethics rules. In 2015, she used a false identity (Janey Wilson) and the confidential information to contact the management of the organization that serves as the domicile for the registered charity to which I donate the proceeds of my book, and made false statements about me to the organization where it is domiciled. A true and accurate copy of the false statements she made is attached and incorporated as part of Exhibit "U". Dr. Prause also reported the charity to the Scottish Charity Regulator, falsely claiming financial fraud involving the charity personnel and myself. A true and accurate copy of the false statements she made about the charity is attached and incorporated as part of Exhibit "V".
- 18. I donate the proceeds of my book *Your Brain On Porn: Internet Pornography and the Emerging Science of Addiction* to The Reward Foundation, a registered Scottish charity. It is defamatory to state that I do not. In emails, on Wikipedia and in the public comment section of the World Health Organization's ICD-11 forum, Dr. Prause falsely claimed that I received over 9,000 pounds from the above charity. A true and accurate copy of the false statements she made about such payments is attached and incorporated as Exhibit "W".
- 19. Over the past 6+ years, Dr. Prause has employed multiple (perhaps dozens of) aliases in violation of Wikipedia rules against sockpuppets (aliases), in order to edit several different Wikipedia pages inserting false and defamatory material about me. This is particularly

damaging as Google presumes information on Wikipedia is reliable, even though it is nearly impossible to correct misinformation on Wikipedia relating to the subject of pornography. Wikipedia itself finally took action against Dr. Prause, citing multiple illicit accounts created by one of her aliases. A true and accurate copy of Wikipedia's disciplinary action blocking her "NeuroSex" account and some of her related aliases is attached and incorporated as Exhibit "X".

20. In addition to the incidents/campaigns described above, Dr. Prause consistently, publicly repeats that I have employed misogynistic language to denigrate her. This statement appears on various social media forums and in public documents. Like her other claims, this is untrue, and the supporting "evidence" does not hold up to close scrutiny. Exhibit "Y".

I declare under penalty of perjury that the foregoing is true and correct. Executed on 22 January, 2020.

Dear Ms. Simmons:

As you know, we are counsel to Dr. Nicole Prause. On May 9, 2019, I wrote to you informing you that your client, Gary Wilson has engaged in a constant barrage of untrue, defamatory attacks upon Dr. Prause. Although I demanded that you inform Mr. Wilson that he would be well advised to cease his false publications and allegations against Dr. Prause, his attacks continue unabated. Mr. Wilson made eight new posts attacking and defaming Dr. Prause yesterday alone.

Mr. Wilson does not appear to realize that every additional false statement and attack he makes against Dr. Prause will increase the damages which will be assessed against him. It is now obvious that not only is Dr. Prause entitled to recover actual damages which have been caused by these attacks, but that Mr. Wilson's malice will entitle her to obtain punitive damages in a large amount. The news media is replete with examples of the kind of punitive damages juries are awarding for the kind of conduct in which Mr. Wilson is engaging.

Dr. Prause has reached the end of her patience with Mr. Wilson. This is to inform you and your client, Gary Wilson, that unless he immediately ceases and desists from his defamatory campaign against Dr. Prause we will file suit against him for defamation, intentional interference with business relations, false light invasion of privacy, and undoubtedly several other causes of action.

The next communication Gary Wilson will receive from Dr. Prause will be a Summons and Complaint. Please counsel your client to cease his unlawful behavior.

Stripchat To Hold Live Cam Therapy Sessions Featuring Sex Doctors

Starting August 1, members of the Sexual Health Alliance will appear on live cam to discuss issues like addiction, infidelity, and relationship conflicts with cam users

CYPRUS—Leading camsite Stripchat, in partnership with the Sexual Health Alliance, will be bringing clinical psychologists, sex researchers and relationship therapists onto its global cam platform to answer viewers' questions (whether they're subscribers or not) about sex addiction and online infidelity. The initiative will kick off Thursday, August 1, with an hour-long cam session with Dr. David Ley.

“Cam users are passionate about cams, but the outside world doesn’t always accept that,” stated Max Bennet, Vice President of New Media at Stripchat. “Cam fans are more likely than other adult fans to struggle with shame and anxiety about their desires. This is a chance for them to get past some of the myths and stigma around porn, and talk to an expert about what science actually says.”

A [recent study by Stripchat](#) showed that:

* 42% of all cam users have experienced anxiety about their cam habits, with 11% reporting frequent or constant anxiety.

- * 31% of married cam users said cam watching had caused conflicts in their relationship.
- * 24% of married cam users said they had fallen in love with a cam performer
- * Women and the very religious were the most likely to spend excessively on cams—over \$1K a month—and to feel shame about it

As part of the campaign, Stripchat solicited questions from its users that they would like a doctor to answer. The questions ranged from fears about sex addiction to worries about mental health.

Stripchat has partnered with the Sexual Health Alliance to help cam users better understand the science behind cam and porn use. SHA Advisory Board member Dr. David Ley will appear on cam on August 1 to discuss the latest research on the origins of sexual shame, online infidelity and sex addiction.

“Webcam users have been left out of most research and therapy,” said Dr. Ley. “Non-shaming support and education is nonexistent. This needs to change, and this is how it starts.”

“Sex Addiction: Myths and Facts” will take place on Stripchat on Thursday, August 1, 2019 at 5 PM ET/2 PM PT.

Why Fascists Hate Masturbation

The rise of nationalism coincides with anti-masturbation movements

In recent years, we've seen the return of a strange, antiquated belief system that claims that [masturbation](#) results in weakness, loss of manhood, and psychological damage. There's nothing really new about this belief – Swiss physician Samuel Tissot promoted the idea in 1760, arguing that semen was an essential oil, the loss of which resulted in decreased strength, [memory](#), reason and [morality](#). Benjamin Rush, a physician and signer of The Declaration of Independence treated masturbation with leaches, and claimed it caused blindness and mental disturbance. Graham and Kellogg, 19th Century physicians invented bland foods like corn flakes and graham crackers to curb the desire to masturbate (I think that Graham didn't anticipate s'mores, which are actually pretty sexy). Kellogg advocated a host of punitive, restrictive measures to prevent children from masturbating, and was an early advocate for circumcision, arguing that it would reduce male masturbation. Christian arguments against the sin of onanism are now understood as a misinterpretation of the story of Onan, which is truly a condemnation of selfishness and depriving a widow and children of inheritance, not actually a condemnation against masturbation. The DSM-I, published in the 1950's by the American [Psychiatric](#) Association offered the diagnostic code of 317.1 for the mental [health](#) disorder of masturbation. But, modern society seemed to have moved away from open condemnation of the dangers of self-pleasure. At least it did, for a few decades.

Just in the past couple of years, we've seen the explosive rise of numerous groups and figures also advocating against the dangers of masturbation:

- The Reddit nofap community is a large group of individuals, who use this online form to tout the health benefits of refraining from masturbating. Predominantly male, and largely young, white and often [religious](#) males, these discussion groups describe how masturbation, especially to porn, lessens men's focus, and interferes in the men being able to get dates or sex from real women.
- Your [Brain](#) on Porn and Reboot Nation are also online groups who argue that masturbation to [pornography](#) results in neurological changes which desensitize a person's brain to real sex, cause [erectile dysfunction](#), and instill an [addiction](#) to Internet pornography. They promote the idea of a 90-day period of abstinence from sex and masturbation, in order to "reboot" the brain, like resetting it back to the original specs before you started watching porn (In case you were wondering this isn't actually how brains work – we never go back, only forward in or neurological development).
- Numerous modern religious communities have condemned masturbation, especially to pornography. Brigham Young university, a Mormon school, spent what appears to be a great deal of money to produce a [public service advertisement](#) against the dangers and "darkness" of masturbation. For decades, Mormon deacons have conducted "[worthiness interviews](#)" of adolescents, centered on detecting and punishing masturbation, a practice now under scrutiny and attack.
- Texas Senator Ted Cruz has taken on the dangers of masturbation, [arguing](#) in 2007 that US citizens have "no substantive due process right to stimulate their own genitals."
- Conservative psychologist and Youtube sensation Jordan Peterson, PhD., has suggested "[there's nothing noble about masturbating to pornography](#)."
- The Proud Boys is a group of young, nationalist males, self-described "Western Chauvinists," who have recently been connected to numerous hate crimes, including public [assaults](#) on gay men. A central tenet of the Proud Boys' belief system is the value

of [#NoWanks](#), claiming that masturbating makes men less likely to get dates and a way to push back against modern liberal culture. An interesting connection exists between NoFap and the Proud Boys – Alexander Rhodes, one of the leaders of the NoFap movement, [appeared](#) in 2016 on Gavin McInnes's show, discussing NoFap and #NoWank. McInnes is the founder of The Proud Boys. Interestingly, that show ended with a clip from porn star Mercedes Carrera (to whom, one might imagine, many men have masturbated). Recently, as The Proud Boys garnered significant negative attention, NoFap issued a [response](#) from their [Twitter](#) account, stating that "Proud Boys has nothing to do with NoFap. They are not affiliated with our organization in any way. NoFap is non-legislative and non-partisan."

- David Duke, associated with the KKK and white supremacy, suggested that pornography was a Jewish conspiracy, intended to serve as a "weapon of revenge" against European (white) men and societies. Duke argues that masturbation in fiction and films is a "[metaphor for Jewish behavior](#)" and cites Breitbart, and alleged masturbation by "[asylum seekers](#)" as a way to argue against immigration. Duke [implores](#) his followers to watch a video by Gary Wilson, founder of Your Brain on Porn.

You may notice that, overwhelmingly, all of these concerns, both historical and modern, about masturbation are primarily focused on male masturbation. Rarely were these arguments concerned with female masturbation. Why? And why, with almost no exceptions, are the leaders of these movements all conservative, religious white men? Conservative media outlet Breitbart [sneers](#) at liberals who "boast of masturbating," apparently because they'd grown "bored of LGBTQI."

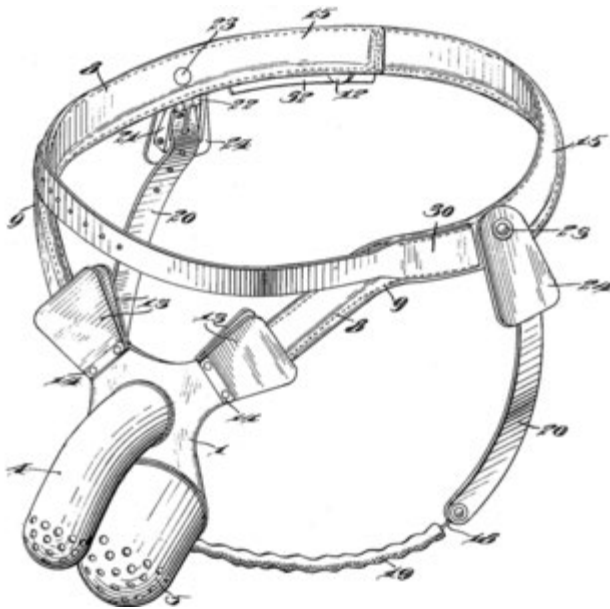

Wilhelm Reich was an early 20th Century psychoanalyst who wrote [The Mass Psychology of Fascism](#) analyzing and criticizing the Nazi Party of 1930's Germany. Reich's book was so controversial that he was kicked out of the Communist Party that he had joined, due to concerns about angering the growing German power. Reich suggested that sexual suppression was a tool of fascism, a way to train young people to submit to authority, even in something relating to their own body. (Note, Reich went on to have some kooky beliefs of his own, about, for instance, the mystical power of the [orgasm](#).)

Suppression of the natural [sexuality](#) in the child, particularly of its genital sexuality, makes the child apprehensive, [shy](#), obedient, afraid of authority, good and adjusted in the authoritarian sense; it paralyzes the rebellious forces because any rebellion is laden with anxiety; it produces, by inhibiting sexual curiosity and sexual thinking in the child, a general inhibition of thinking and of critical faculties. In brief, the goal of sexual suppression is that of producing an individual who is adjusted to the authoritarian order and who will submit to it in spite of all misery and degradation. At first the child has to submit to the structure of the authoritarian miniature state, the family; this makes it capable of later subordination to the general authoritarian system. The formation of the authoritarian structure takes place through the anchoring of sexual inhibition and anxiety. [Wilhelm Reich](#).

Religions, and particularly the conservative religions which form the backbone of modern conservatism, have a long history of condemnation of masturbation. Masturbation feels good, and is a private source of erotic pleasure which leads one to be more comfortable with one's own body, and with sexuality in general. Our bodies, and sex in particular, are associated with "the mortal plain," leading us to focus on or sensations and physical existence. But religions, and conservative [politics](#), want us to focus on other things, aspiring to some higher "nobility" as Peterson suggests.



19th Century Anti-Masturbation Belt

Masturbation is the healthiest human sexual behavior, associated with a range of health and life benefits, with no known (to science or medicine) health risks. It is [pregnancy](#) and disease free. It teaches people to accept and understand their own sexuality. Healthy sexual and marital relationships are improved by masturbation, when the [shame](#) and stigma of it are removed.

It would be easy, but likely foolish, to spin a theory that all of these modern anti-masturbation movements reflect secret Machiavellian plans to infiltrate the minds of young men and make them susceptible to authoritarian influence. [Hanlon's Razor](#) suggests that it is a waste of time to

attribute to conspiracy, what can be adequately explained by mere stupidity. The hatred of masturbation by these various conservative men may also reflect [fear](#), as opposed to stupidity. Most of them seem to have religious backgrounds, and likely grew up being taught to suppress their desires for anything other than heterosexual monogamy. The modern world, the “liberal world” as the Proud Boys decry it, offers many varied sexual experiences, apart from a heterosexual [marriage](#). Perhaps that diversity of opportunities, and their own fear of their ability to resist them alone, drives these campaigns for communal resistance against masturbation?

Gary Wilson's reply to Dr. Prause's first DMCA attempt (3/28/18)

Dear Linode,

Dr. Prause claims that "Images of my likeness posted throughout www.yourbrainonporn.com." This is untrue. The only image of Prause was at this url - <https://www.yourbrainonporn.com/libelous-claim-gary-wilson-was-fired> (now removed).

It appeared in a screenshot of an article Prause herself posted on an adult video blog, which contained libelous statements about me. (She posted, and mischaracterized, an employment document of mine, falsely claiming I had been fired. This document was subsequently removed via my DMCA takedown request.) I have now removed the image of Prause from that page, but it is Prause who made it public to harass and libel me. None of the other urls given by Prause contain images of Prause or images that she owns.

It's disturbing that Prause claims to be a victim here, as I have documented multiple instances of her harassing myself and others - including researchers, medical doctors, therapists, psychologists, former UCLA colleagues, a UK charity, men in recovery, a TIME magazine editor, several professors, IITAP, SASH, Fight The New Drug, the academic journal Behavioral Sciences, and the head of the academic journal CUREUS: <https://www.yourbrainonporn.com/nicole-prauses-pdf-her-span-lab-website>

No one appears to be stalking Prause. It is she who stalks and harasses others. Most of my site's references to Prause are on the above page that chronicles 5 years of Prause harassing and libeling me and others.

As for other places where Prause name appears, YBOP contains about 10,000 pages, and it's a clearinghouse for nearly everything associated with Internet porn use and its effects on the user. Nicole Prause has published multiple studies about porn use and hypersexuality, and by her own admission, is a professional "debunker" of porn addiction and porn-induced sexual problems.

A Google search for "Nicole Prause" + pornography returns about 9,000 pages. She's quoted in hundreds of journalistic articles about porn use and porn addiction, in addition to her research related to pornography use. She's on TV, radio, podcasts, and YouTube channels claiming to have debunked porn addiction with a single (heavily criticized) study. So Prause's name is inevitable on a site like mine, which functions as a clearinghouse for research and news associated with Internet porn's effects. YBOP also critiques Prause's studies other questionable research on porn and related subjects. These critiques are not personal, but rather substantive.

This DMCA take-down request is just the latest in a long string of harassment incidents by Prause. Dr. Prause has tweeted about me nearly 100 times, while I never tweet about her (other than correcting a few of her lies). Prause has used dozens of fake usernames to post comments about me on porn recovery forums (<https://www.yourbrainonporn.com/nicole-prauses-pdf-her-span-lab-website#ybr>) Prause has created an amazon AWS page to libel and harass me and many others (https://s3-us-west1.amazonaws.com/weilerdefamation/PressRelease_DefamationBySenatorWeiler.txt)

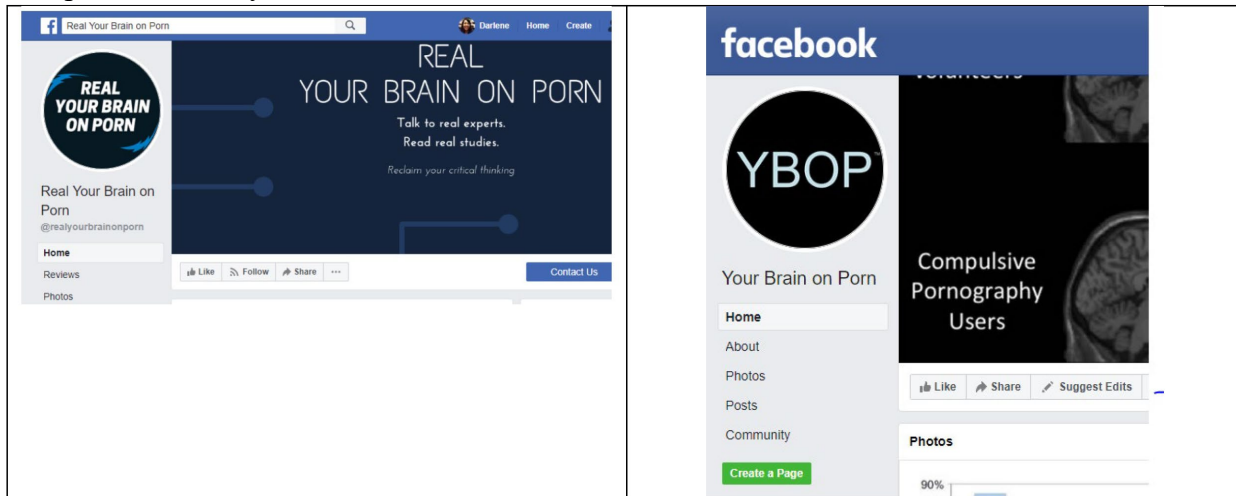

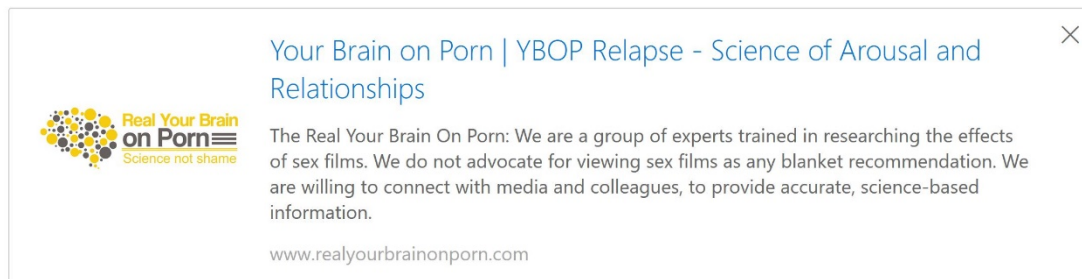


Comparison of Gary Wilson’s Facebook and the RealYourBrainonPorn Facebook:



Dear Mr. Giampietro:

We acknowledge that we received your August 27, 2019 letter sent on behalf of your clients, Mr. Burgess and Dr. Prause and provide the following in response on behalf of Mr. Wilson (doing business as Your Brain On Porn). We respond first to the false and libelous statements that you made in your August 27, 2019, letter. We then address the actions recently taken by a website and social media that appears to be under the control of your clients, which impugns Mr. Wilson's reputation.

August 27, 2019 letter

The false statements that you made about our client in your August 27, 2019 letter include the second and third sentences of that letter. You falsely stated:

1. That Mr. Wilson illegally interfered with your client's [Mr. Burgess'] website;
2. That Mr. Wilson illegally altered the archives of your client's [Mr. Burgess'] website, www.realyourbrainonporn.com;
3. That Mr. Wilson provided public instructions for others to alter illegally the archives of your client's [Mr. Burgess'] website.

You and your client also published these false statements via Twitter within a half hour of your firm emailing us your August 27, 2019, letter. Your and your client's statements listed above are false and actionable. Mr. Wilson assures us that he has never "interfered with" the content of the website www.realyourbrainonporn.com or the archives for that website. Nor has he claimed that Mr. Burgess or Dr. Prause inserted pornographic material "on his website." You do not offer evidence to support either claim.

In his August online communications, Mr. Wilson demonstrated how false archive entries can be attributed to an existing archive. This was done to counteract the false archive listings someone created for Mr. Wilson's website. These false, nonexistent URL addresses (with no underlying

content) could be inserted into the list of archived URL addresses captured in the Wayback archive. This can apparently be accomplished for any website's page in the archive, and can thus be employed maliciously to smear anyone whose website pages have been archived.

The fake archives were designed to fraudulently make it appear that Mr. Wilson had engaged with Mormon porn subject matter. In response to your clients' vocal, public campaign falsely insisting that Mr. Wilson inadvertently created hundreds of URL addresses on his site by viewing porn, Mr. Wilson demonstrated the following:

- He tweeted a screenshot showing that it is easy to create and insert false URL addresses on the archive for his YourBrainOnPorn.com site on the Wayback archive.
- He tweeted a screenshot showing that someone else had subsequently created at least two false URL addresses on the RealYourBrainOnPorn.com Wayback archive page.
- He revealed the "//" coding ruse in the false "porn" URL addresses, which ensured that the offensive, fake URL addresses all rose to the top of the 100,000-page collection of URL addresses in the Wayback archive related to YourBrainOnPorn.com.

None of his actions could possibly constitute interference in *your client's* website. They were done only to demonstrate the malice of whoever inserted the false URL addresses into the Wayback archive page for www.yourbrainonporn.com, which false materials were promoted solely and extensively via your clients' social media. Nor was Mr. Wilson responsible for the sample fake URL-address insertions on the RealYourBrainOnPorn archive page, which he shared on Twitter. He merely publicized their existence after learning of them, in order to undermine your client's ongoing campaign to impugn his reputation on your client's social media account by insisting that fake URLs couldn't be posted to the Wayback archive.

Email and "Brain On Porn" Twitter campaign

As you know, when Mr. Wilson filed his UDRP complaint, WIPO revealed that Mr. Burgess has been holding the domain name registration for and the URL www.realyourbrainonporn.com since at least April, 2019. Mr. Burgess apparently controls the existing website with Dr. Prause, as you mentioned this fact in your August 27, 2019 letter, despite previously misrepresenting to us that she was not involved in the site.

We presume that Mr. Burgess also controls both the website's email function, which uses an alias based on the other name of Mr. Burgess' website www.sciencearousal.com (before he switched to the www.realyourbrainonporn.com address), and all of the social media accounts that use the name "Real Your Brain On Porn" and derivations thereof. That email account and corresponding social media participated in the campaign to impugn Mr. Wilson's character.

Email – Amid the aforementioned social media campaign to persuade people that Mr. Wilson is a reckless porn user with unsavory porn tastes, your clients sent the following email, which they knew was untrue, on August 22, 2019, using Mr. Burgess' domain. The recipient forwarded it to Mr. Wilson:

Filter/search for "Mormon" to show the pornography content. He has not provided any reason other than he accidentally uploaded his own porn searches to his anti-porn website.

He may have joined the movement to get access to those girls. He has not denied that the text was on his website; he only claims that it is some conspiracy against him. This is what predators do.

These claims of professional and sexual misconduct are without authentic support (as explained above), and are harmful to our client's reputation particularly in his profession.

Social media

While an alleged "Ron Swanson" was the first to publicize the tale about the false URL addresses (screenshot #1 below), Dr. Prause sent tweets containing false information about the false URL addresses (screenshot #2), which was swiftly followed by a Twitter rampage that lasted for days (involving more than 100 tweets), conducted by a Twitter account that we think is controlled by Mr. Burgess or Dr. Prause, <https://twitter.com/BrainOnPorn>. This Twitter campaign attempted to spread and legitimize the groundless campaign based on false Mormon porn URLs (with no underlying content).

In addition to the character-impugning campaign conducted by the @BrainOnPorn Twitter account, that Twitter account also explicitly accused our client of at least 3 felonies (screenshots attached):

- Stalking women in person
- Making death threats, and
- Hacking into websites.

As your clients know, to falsely, publicly accuse people of sexual/professional misconduct and criminal action in the nature of felonies is actionable in itself. In fact, if a tribunal deems such actions "defamation *per se*," Mr. Wilson need not show any commercial damages in order to recover. Mr. Wilson is separately considering the remedies open to him to seek redress for your clients' actions. Settlement terms as to these facts would need to be addressed separately from the proposed settlement concerning Mr. Wilson's trademark.

This letter is not intended as a complete statement of the facts or of Mr. Wilson's rights, remedies, and causes of action, all of which are expressly reserved.

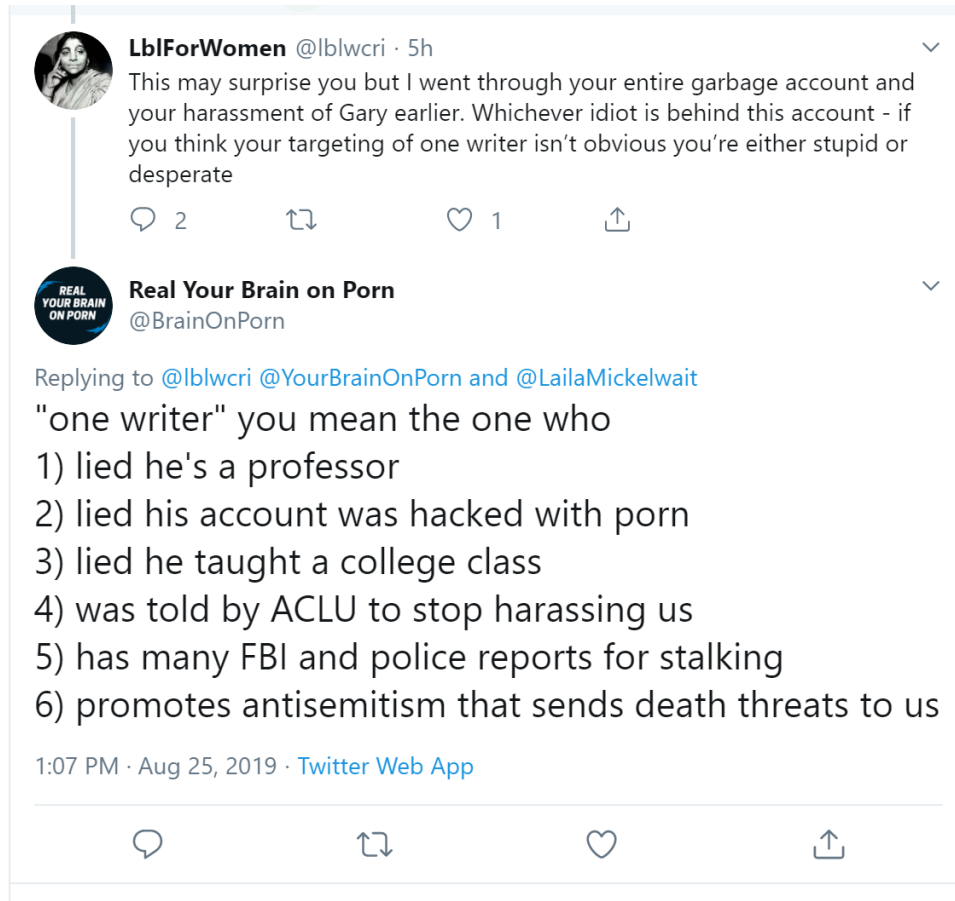

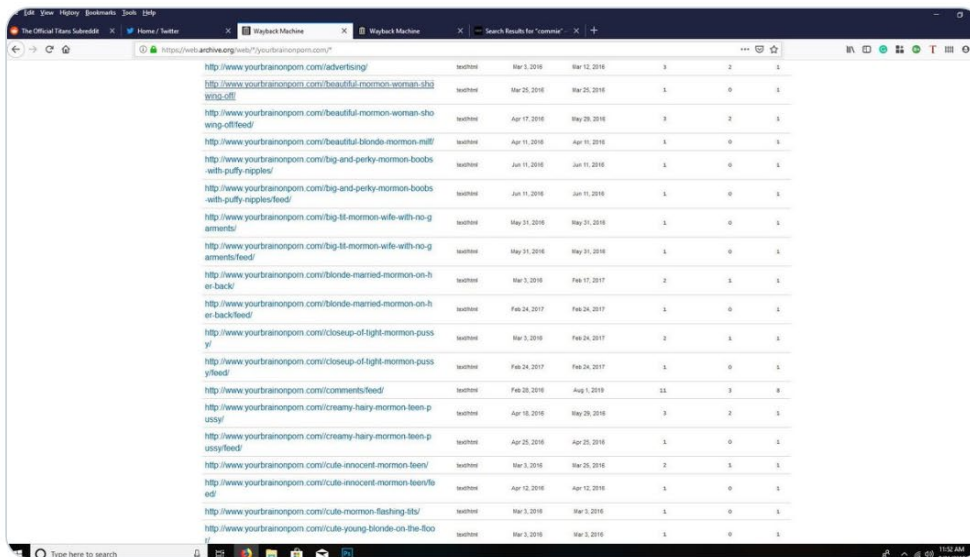

Dear Ms. Simmons:

The demand in your May 1, 2019 letter to a group of academics and practitioners associated with the web site Real Your Brain On Porn that they "[r]efrain from disparagement and defamation of YOUR BRAIN ON PORN and its principal and associates" is misguided for numerous reasons.

To the extent you are using disparagement to mean criticism or belittlement, as it is ordinarily defined, the request is improper. Criticism is protected by the First Amendment to the United States Constitution in the absence of both a provably false statement of fact about the person who claims he was injured, and the requisite level of fault, such as negligence or malice.

But, even if you are using disparagement to refer to a legal tort such as commercial disparagement, there is no basis to suggest that Real Your Brain on Porn has ever disparaged Your Brain on Porn, its principal, Mr. Gary Wilson, or his associates. First, the website does not mention Your Brain on Porn except in a disclaimer on the bottom of page of the website that states, "This web page has no relationship with yourbrainonporn.com." Nor does the website ever mention Mr. Wilson or his associates. To prevail on a claim of disparagement, however, a plaintiff generally needs to show that there is both a false or misleading statement and that it specifically refers to the plaintiff. See, e.g., *Harford Casualty Ins. Co. v. Swift Distribution*, 59 Cal.4th 277, 293-94 (2014). Because Real Your Brain on Porn does not refer to Your Brain on Porn (except in the no relationship disclaimer), Mr. Wilson, or his associates or make any false statements about them, there is no basis for you to demand that the publisher of the website or anyone associated with it refrain from disparagement of Your Brain on Porn, Mr. Wilson, or his



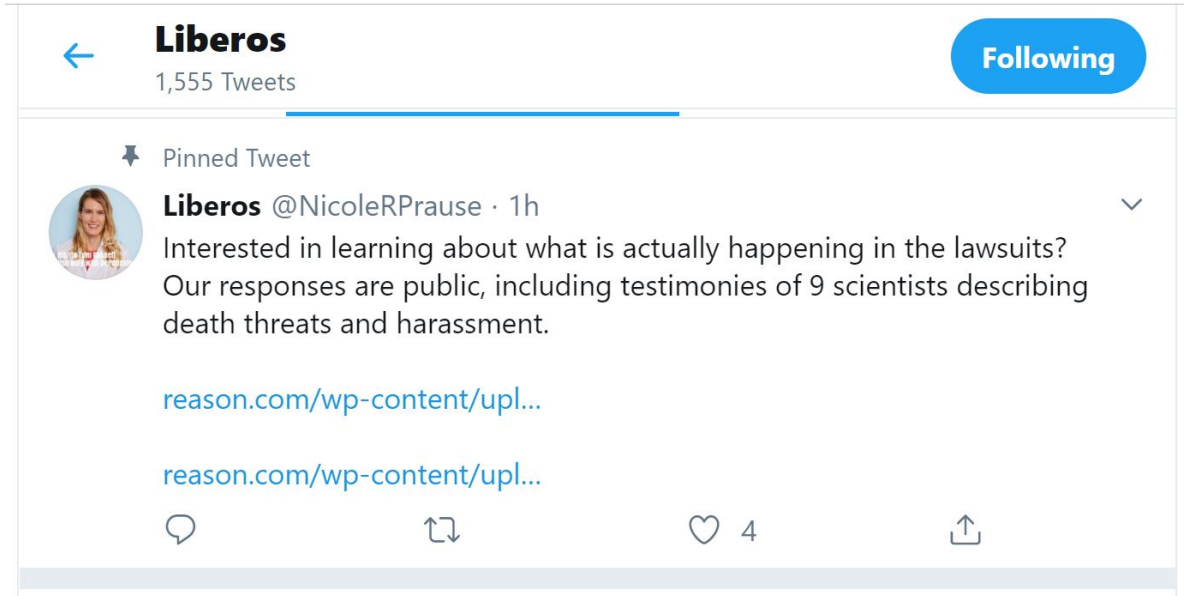

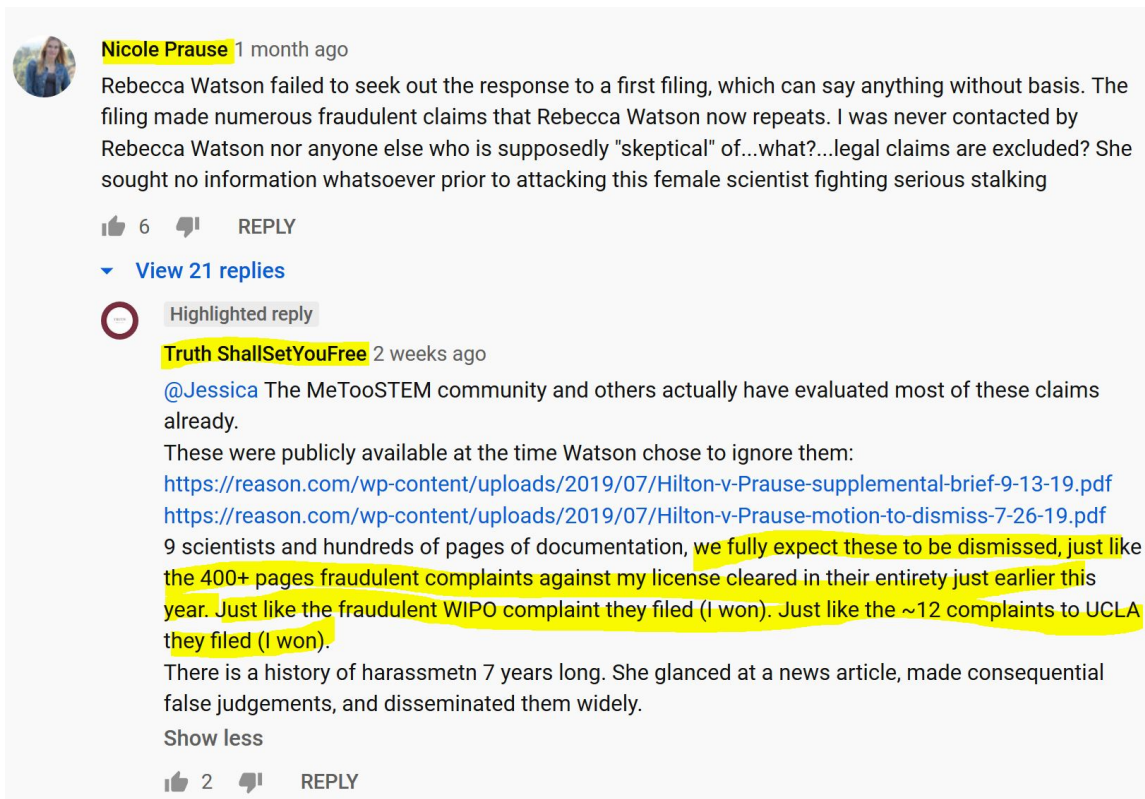

Prause wrote, “Dear Cru, As you consider how to express your personal values around sex films, I encourage you to consider not promoting sexual harassment in your selection of Fight The New Drug for a presentation.”

Prause wrote about her experiences with an individual that she had filed a stalking report against with the Los Angeles Police Department. Prause explained that this individual is used as a resource on Fight the New Drug’s (FTND) website. The individual is cited in 21 articles on **FTND’s website**.

In an interview with *The Racquet*, Prause said, “So, when Fight the New Drug started posting his stuff, I was just floored.” Prause went on to say, “Anyone’s allowed to have their opinion about this stuff, but do not promote someone who is stalking and threatening scientists. Like, that is not a joke.”

Later, after being asked if anyone from Cru had responded to Prause’s email, Cru Area Director Luke Rickert said, “I did not know we were supposed to have a response to that. She did not ask a question or elicit any kind of action. I felt like it was an opinion that she had.” Prause stated that she did not receive a response from UWL’s Equity and Affirmative Action Office either. The office declined a request for comment.

This email raised a question about FTND: Should UWL students use them as a reliable resource regarding information about pornography?
