This was a systematic review of the content in those forums. I believe Ley's point is not to say everyone must masturbate at some regular schedule. If you choose not to masturbate, just don't promote for-profit groups that support misogyny and advertise Proud Boys and other antisemitic groups. As far as I am aware, the only celebrity fan of YourBrainOnPorn is David Duke, which he described as preventing race mixing.

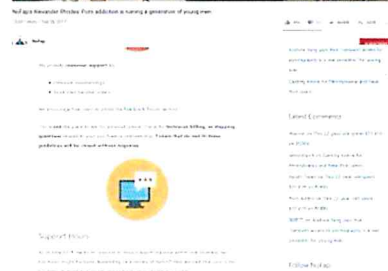

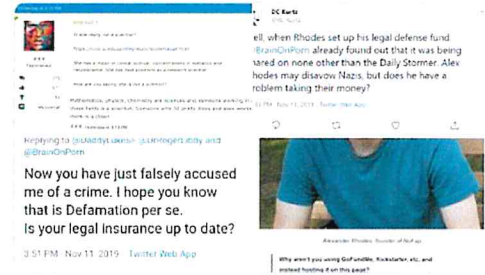

Alexander Rhodes, the owner of the NoFap trademark, filed a complaint against a neuroscientist who studies porn and sexuality for libel and defamation.

Rhodes founded NoFap in 2011 after—as he reveals in the lawsuit—a lifelong addiction to porn beginning at age 11, aiming to help men refrain from extensive masturbation. The tenets of the NoFap website state that it's merely trying to help people break their porn addiction by abstaining from masturbating. The website is careful to claim that it's just a website, not a movement, even though it was spawned from an associated subreddit with 515,000 subscribers and a Twitter account with more than 19,000 followers. The website is most commonly associated with #NoNutNovember, an online challenge in which men try not to masturbate or otherwise orgasm for a month.

The lawsuit is aimed at Nicole Prause, a neuroscientist studying sexual science through a neuroscience and physiology lens who found no scientific basis for "porn addiction."

"These online communities have whipped themselves into a frenzy when in the past men wouldn't have been concerned," Prause told the Guardian in 2016. "Then the next time they go to have sex they are

"This makes it tremendously difficult for critics of these anti-masturbation campaigns to reach an audience, because they can't use 'NoFap' without fear of legal retribution. As a result, scientists, therapists and others who have spoken out about the anti-masturbation community's anti-semitism, misogyny and harassment find themselves targeted if they use the phrase."

We are counsel to Dr. Nicole Prause, who has requested that we contact you regarding articles published by your organization written by Diana Davison containing untrue accusations against Dr. Prause. While we recognize the right of journalists to write about matters of public interest, and to even editorialize in their writing, it is universally understood that it is defamation to publish allegedly factual material which is known to be false.

Indeed, we even recognize that individuals may engage in bad journalism from time to time. However, Ms. Davison has maliciously published information on the Post Millennial's website which she knew to be false at <https://www.thepostmillennial.com/porn-wars-get-personal-in-no-nut-November/>. She has also posted this same material on her Twitter account, representing herself as speaking for the Post Millennial (<https://twitter.com/d2davidson>) and on YouTube, again representing herself as speaking for the Post Millennial (<https://www.youtube.com/watch?v=Kn6Vpx7bQ3w>). In each instance, she ignored the actual legal documentation in her possession which proved without a doubt that her statements were knowingly false. That is the standard for defamation *per se*.

Included in the false and defamatory claims she made about Dr. Prause were:

- 1) Dr. Prause is in the porn industry because she attended the XRCO awards
- 2) Dr. Prause attended the porn awards, and her "alibi" that she did not attend the AVN award ceremony did "not check out"
