**DECLARATION OF DARRETT "D.J." BURR**

My name is Darrett Burr. Professionally, I go by D.J. Burr. I am older than 18 years of age, I am of sound mind, I have never been convicted of a felony, I am personally familiar with the facts stated herein, and I am fully capable of making this affidavit. I swear under penalty of perjury that the statements contained herein are based on my personal knowledge and are true and accurate.

I am a licensed psychotherapist (Licensed Mental Health Counselor, License Number LH60237239), a Specialist in Problematic Sexual Behavior, the author of the book, *I Just Wanted Love: Recovery of a Codependent, Sex and Love Addict*. My memoir chronicles my extensive history as an addict and details my recovery journey. My work as a psychotherapist is almost exclusively dedicated to helping those affected by early childhood trauma, codependency, and compulsive/out of control sexual behavior or sexual addiction, including, but not limited to, pornography addiction. As detailed more fully below, I have been attacked online and have been falsely accused by Nicole Prause, I believe because I disagree with her on the issue of whether pornography is addictive.

**I. Harassing Complaints to Regulatory Body**

Dr. Prause made a formal complaint against me to regulatory body: Washington State Department of Health. The complaints contained false accusations against me which maligned my character.

**A. Complaints by Dr. Prause against me to the Washington State Department of Health**

Dr. Prause made an unfounded complaint to the Washington State Department of Health on April 8, 2019, which was dismissed without investigation. Dr. Prause falsely claimed that I publicly threatened to file a false complaint against her, using racist language. She further alleged that I provide "fake therapy for-profit" and I am unable to evaluate evidence and provide care to patients because I identify as a sex addict in recovery, which according to Dr. Prause there is no

diagnosis for sexual addiction or compulsive sexual behavior.

## II. Public Bullying, Harassment, and Libel

Dr. Prause does not allow for civil discussion on social media. She lashes out when I post material about sexual addiction, citing her research claiming sexual addiction does not exist, and then she blocks me, preventing me from responding. I am also unable to see further statements she makes about me after I am blocked. She has accused me of malpractice, encouraged people to file complaints against me, and then said she would support them in their efforts.

I find it reprehensible that Dr. Prause attacked me, a black male, and then called me a racist, which is, by definition, false.

A true and accurate copy of the complaint is attached.
