

## [RealYourBrainOnPorn](#) and [Nicole Prause](#) tweets about the [World Intellectual Property Organization](#) decision.

My attorneys filed a complaint with the World Intellectual Property Organization (WIPO) as a possible route to having the trademark-infringing website [www.realyourbrainonporn.com](http://www.realyourbrainonporn.com) removed from the Web as swiftly and economically as possible. While the arbitrator declined to support its removal, he acknowledged that the infringing URL was indeed “confusingly similar” to my URL [www.yourbrainonporn.com](http://www.yourbrainonporn.com). He then decided that the infringing site was a “gripe” site, and as such, entitled to criticize my site.

My attorneys say it is not, in fact a “gripe site.” It does not criticize my work. In fact, it does not address the content of my site at all, and merely holds itself out as the “real” version of my site in a confusing manner. However, the arbitrator, having opined that the infringing site was a “gripe site,” declined to examine the third element of my complaint: Prause's abundant bad faith. He stated that the evidence my attorneys provided “could well suffice to establish bad faith,” but found no need to reach a conclusion on that element in view of his “gripe site” opinion. **This is far from over.**

It goes without saying that Prause's [attempt to steal my trademark](#), while mimicking the appearance of my website and Twitter account, reveals [she is the aggressor, the obsessed harasser](#). She is not the victim, [but the perpetrator](#).

Prause has weaponized the [WIPO decision](#) via a press release and constantly tweets a link to the WIPO page as if it exonerates her entirely. Below are examples of Prause and RealYBOP twitter obsessively trolling me to tweet the WIPO decision.

Not only does RealYBOP (Prause?) incessantly tweet a link to the WIPO decision (often entering my Twitter threads to do so), RYBOP incorrectly calls WIPO a “lawsuit,” and regularly tweets (falsely) that other “porn activists” were involved in my case.

While spending her waking hours harassing others, Prause cleverly cultivated – with zero verifiable evidence – a myth that [she was “the victim”](#) of most anyone who dared to disagree with her assertions surrounding porn’s effects or the current state of porn research. To counter the ongoing harassment and false claims, YBOP was compelled to document some of Prause’s activities. Consider the following pages. 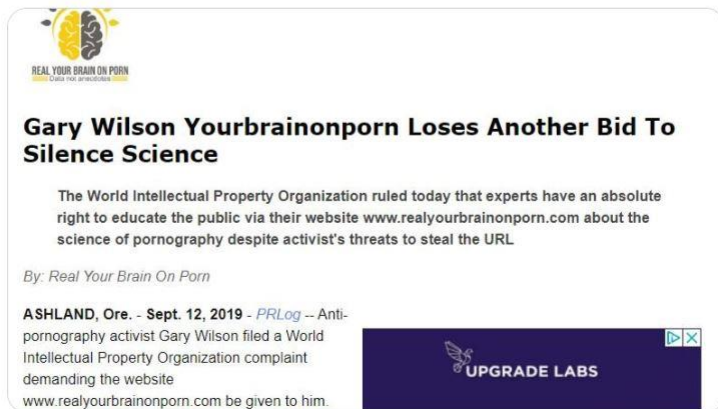

"This is a huge win for science!", exclaimed Nicole Prause, PhD, an expert listed on the website. "This activist has threatened many of us, and WIPO agrees that he cannot continue."

Wilson sent cease and desist demands to nearly 30 experts on the website. The American Civil Liberties Union responded "Criticism is protected by the First Amendment to the United States Constitution. Please refrain from making unsupported and misguided demands against Real Your Brain on Porn and people associated with it in the future" Wilson failed to heed their advice.

"When he identified me as owning the website, he began linking to images of my family, who have no role whatsoever in this", said Daniel Burgess, LMFT, "he proved I was right to try to protect my safety, and the safety of my family, by not advertising my participation in sharing this science."

Some therapists who profit from treating pornography as addictive have encouraged Wilson's threats. Staci Sprout, a CSAT therapist certified by International Institute for Trauma and Addiction Professionals, complained "Talk about perpetrating from the (false) victim place—this group is toxic. Who are the members of this "Real(not) Your Brain On Porn?" leading Wilson to dox the experts. The Society for the Advancement of Sexual Health named Wilson as their "media award" winner. Alexa analyses show Wilson's website visitors are 98% male and 96% under age 24, raising questions about whether these young men are being taken advantage of.

Five experts from [www.realyourbrainonporn.com](http://www.realyourbrainonporn.com)/experts received antisemitic death threats last year. Wilson appeared on multiple white supremacist shows, making him a person of interest in these threats. Law enforcement is working with these experts to find and prosecute the person(s) responsible.

In the mean time, these experts are now free to continue to use their free speech rights to educate the public.

But, even if you are using disparagement to refer to a legal tort such as commercial disparagement, there is no basis to suggest that Real Your Brain on Porn has ever disparaged Your Brain on Porn, its principal, Mr. Gary Wilson, or his associates. First, the website does not mention Your Brain on Porn except in a disclaimer on the bottom of page of the website that states, "This web page has no relationship with yourbrainonporn.com." Nor does the website ever mention Mr. Wilson or his associates. To prevail on a claim of disparagement, however, a plaintiff generally needs to show that there is both a false or misleading statement and that it specifically refers to the plaintiff. See, e.g., *Harbort Casualty Ins. Co. v. Swift Distribution*, 59 Cal.4th 277, 293-94 (2014). Because Real Your Brain on Porn does not refer to Your Brain on Porn (except in the no relationship disclaimer), Mr. Wilson, or his associates or make any false statements about them, there is no basis for you to demand that the publisher of the website or anyone associated with it refrain from disparagement of Your Brain on Porn, Mr. Wilson, or his

understanding of the field.

Many of us left SASH when Mr. Wilson and Mrs. Robinson joined SASH. While the reasons are multifactorial, one of our concerns was the direction SASH was taking, once again, to be restrictive and insular. Mr. Wilson will only engage in academic discourse through his blog. He does not publish his own studies. He actively requested that the publication of the special edition of SAC be halted, rather than contribute a letter to the editor or publish his own research. More concerning, information has come to light about potential integrity and affiliations. I have attached documentation that is widely available in the public domain and have been circulated on social media. Finally, we are concerned that Mr. Wilson and Mrs. Robinson are utilizing SASH to propagate their agenda as opposed to fully embracing the mission of SASH.

We believe Mr. Wilson and Mrs. Robinson should be asked to answer the following questions to the board:

- 1) What are Mr. Wilson's credentials? How does he respond to criticism that he misrepresents those?
- 2) What is Mr. Wilson's relationship with certain members of known hate groups? Why did he feel it was appropriate to promote his work through those channels?
- 3) Are Mr. Wilson and Mrs. Robinson open to discussion of alternative perspectives on pornography? Where does that fit in to the trainings developed by SASH?

Our goal is to help preserve the reputation and integrity of an organization we worked incredibly hard to create. We fully acknowledge it is up to the current leadership to determine the role Mr. Wilson and Mrs. Robinson play in the organization. However, we could not remain silent about these concerning issues.

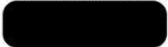

## Gary Wilson Yourbrainonporn Loses Another Bid To Silence Science

The World Intellectual Property Organization ruled today that experts have an absolute right to educate the public via their website [www.realyourbrainonporn.com](http://www.realyourbrainonporn.com) about the science of pornography despite activist's threats to steal the URL

Anti-pornography activist Gary Wilson filed a World Intellectual Property Organization complaint demanding the website [www.realyourbrainonporn.com](http://www.realyourbrainonporn.com) be given to him. This website was created by experts to provide accurate information about science regarding the effects of pornography. Wilson's complaint was "denied" today.

Wilson claimed "They never address substance, never" referring to scientists whose research disagrees with him. The WIPO ruling shows this is because he regularly threatened these experts. Wilson possesses no college degree and has a

seven year history of reports with federal and local law enforcement for threatening professionals. [www.realyourbrainonporn.com](http://www.realyourbrainonporn.com) provides experts a safe outlet to communicate balanced science.

"This is a huge win for science!", exclaimed Nicole Prause, PhD, an expert listed on the website. "This activist has threatened many of us, and WIPO agrees that he cannot continue."

Wilson sent cease and desist demands to nearly 30 experts on the website. The American Civil Liberties Union responded "Criticism is protected by the First Amendment to the United States Constitution...Please refrain from making unsupported and misguided demands against Real Your Brain on Porn and people associated with it in the future". Wilson failed to heed their advice.

"When he identified me as owning the website, he began linking to images of my family, who have no role whatsoever in this", said Daniel

Burgess, LMFT, "he proved I was right to try to protect my safety, and the safety of my family, by not advertising my participation in sharing this science."

Some therapists who profit from treating pornography as addictive have encouraged Wilson's threats. Staci Sprout, a CSAT therapist certified by International Institute for Trauma and Addiction Professionals, complained "Talk about perpetrating from the (false) victim place—this group is toxic. Who are the members of this "Real(not) Your Brain On Porn"? leading Wilson to dox the experts. The Society for the Advancement of Sexual Health named Wilson as their "media award" winner. Alexa analyses show Wilson's website visitors are 98% male and 96% under age 24, raising questions about whether these young men are being taken advantage of.

Five experts from [www.realyourbrainonporn.com/experts](http://www.realyourbrainonporn.com/experts) received antisemitic death threats last year. Wilson appeared on multiple white supremacist shows, making him a person of interest in these threats. Law enforcement is working with these experts to find and prosecute the person(s) responsible.

In the mean time, these experts are now free to continue to use their free speech rights to educate the public.
